# E. ANNUAL PUBLIC MEETING – OPEN DISCUSSION

Mr. David Douglas, rider, Exalted Ruler, Inverness Elks Lodge #2522, expressed concerns about how many bags are allowed on the bus and how they can be managed. He would like to have a meeting, including himself, to discuss this issue where no one has a fear of getting hurt or bags toppling. It was suggested he get with Mr. Frye and discuss this further.

Ms. Patricia Ryder stated she rides both bus lines. She also has a concern about carrying 3 bags. She made a suggestion of the rolling suitcase like carriers.

Another concern she expressed is seniors that don't have a lot of money but need to go to, for example, dialysis three times a week, getting a break on the cost of riding.

Another concern is cross county hours with transfers, making for a long day. Mr. Frye suggested the deviated Fixed Route with the para transit because they complement each other stating he would work with her.

Danny Marianas, The Path of Citrus County, spoke about transportation to Ocala for services, mostly to the Social Security Office. He asked to consider a shuttle to Ocala.

Reverend Joan Clark, representing Shepard of the Hills Episcopal Church and the SOS Food Pantry, spoke about the basic needs people have for food let alone transportation. They can feed 150 families in a 3 hour stint on Thursday mornings. They have 300 families registered but they can only come every other Thursday to get their food. These people, who live in cars, tents and wherever they can find shelter, need to be able to have access to government services, but they can't access them if they are in Ocala. I'm pleading for at least once a week a regularly schedule bus / van run to Ocala for these people. Vice Chairman, Dominic Christofaro said we can only make recommendations to the BOCC who is the ultimate authority. Mr. Frye said this is very important getting input from the community which gives us guidance to take to the decisions makers.

Mr. Terrance Garrity, Terri's Taxi, offered to lease a bus from CCT for \$1.00 and he would get transportation to Ocala one day a week, free of change for anyone who wants to take it. He also said he will pay for the gas and the insurance.

Mr. Garrity also said he would do whatever he could, until we get something in place, with a minivan, to get people to the food pantry one day a week. If you lease me a bus for \$1.00 I will do the same thing for these people as going to Ocala.

Ms. Paula Holtsclaw, Mid Florida Homeless Coalition, expressed the need to get to the Social Security Office in Ocala stating they are willing do anything they can to help get this issue before the BOCC.

Renea Teaster, Facilitator for the Community Alliance of Citrus County, expressed concern about getting those who need it to the Social Security Office in Ocala.
